However, despite its potential, biomethane's market uptake remains uneven across EU Member States due to **policy fragmentation**, **regulatory barriers**, **and financial uncertainties**.

This workshop, organized within the framework of the Horizon Europe GreenMeUp project, brings together policymakers, industry leaders, and sectorial experts to discuss the current state of biomethane in Europe and strategies to accelerate its market adoption.

Key focus areas

- **Policy Impulse** Current EU policy efforts to enable a higher biomethane market uptake in the EU and exemplary policy measures in leading countries such as Germany, and Italy.
- **Remaining barriers and potential solutions** Results from GreenMeUp's policy design in European countries with emergent biomethane markets (e.g. Poland, Latvia, Estonia, Greece, Czech Republic)
- Market Development Strategies Identifying pathways to scale biomethane in diverse sectors such as heat, electricity, and transport.
- **Innovation and R&I Gaps** Addressing technological advancements and research priorities to enhance biomethane production and integration.

Through expert presentations, panel discussions, and interactive dialogues, this workshop will provide actionable insights and foster cooperation between key stakeholders to ensure biomethane becomes a competitive and reliable energy source across Europe.
